

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, the Fiscal Year for 1990-91 for the White Mountain Apache Tribe commenced on May 1, 1990; and

WHEREAS, as of this date the new Fiscal Year budgets has not yet been reviewed and approved by the Tribal Council due to the recent election and transition; and

WHEREAS, pending final review and approval of the FY 90-91 budgets, it is essential that the Tribal Council authorize by resolution a continuation for the operations of all Tribal Departments and Enterprises except the Chairman and Vice-Chairman Office and the Livestock Association (Refer to previous resolution) pursuant to the Department and Enterprises respective 1989-90 annual budgets prorated at 1/12 for 60 days or until the new budgets are approved.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes all existing Tribal Departments and Enterprises, except the ones noted above, to continue operations pursuant to the Departments and Enterprises respective 1989-90 budgets prorated at 1/12 for 60 days from May 1, 1990 until the new budgets are approved; and

BE IT FURTHER RESOLVED that the Tribal Chairman and Vice Chairman's Office are exempted due to the change of administration and subsequent related expenses of starting new offices and staff; and

BE IT FURTHER RESOLVED that the Livestock Association is also exempted by previous Resolution No. 12-89-293 which stated Tribal aid will cease on April 30, 1990; and

BE IT FURTHER RESOLVED that until the Budgets are approved and far more formal financial guidelines are implemented the following controls will be followed:

1. No capital purchases
2. Freeze on all new hiring (full-time and part-time)
3. Freeze on all promotions and increase pay adjustments
4. Eliminate all contract labor payments
5. Freeze on all non-essential expenses, i.e., donations, staff parties and restaurant charges, etc.



Any exceptions shall be requested in writing and approved by the Tribal Chairman.

The foregoing resolution was on May 4, 1990, duly adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (a) (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
