

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

- WHEREAS, Ms. Rayetta M. Kane, Director of the White Mountain Apache Save the Children Federation has come before the Tribal Council this date and advised that pursuant to a cultural exchange program with the Choctaw Tribe of Mississippi, she and a select group of White Mountain Apache youth will visit the Choctaw Indian Reservation July 5-18, 1990 and on behalf of the children requests that the Tribal Council recognize them in a letter of introduction as youth ambassadors of the White Mountain Apache Tribe; and
- WHEREAS, as participants to the summer youth cultural exchange hosted by the Choctaw Indian Tribe, certain White Mountain Apache children will be attending a pow-wow, workshops, and conferences sponsored by the Choctaw Indian Tribe and Save the Children Federation; and
- WHEREAS, Ms. Kane requests that the Tribal Council also provide a gift to be presented to Chief Phillip Martin of the Choctaw Indian Tribe which would be representative of the culture and traditions of the White Mountain Apache Tribe; and
- WHEREAS, Ms. Kane further advises the Tribal Council that Apache youth representing the Tribe are also scheduled to travel to the reservation of the Hualapai Tribe of Arizona at Peach Springs on May 25-27, 1990 during the Sobriety Festival and thereafter June 23-24, 1990 for a presentation at the Gila River Cultural Center and Heard Museum, respectively; and
- WHEREAS, Ms. Kane advises the Tribal Council that Save the Children Federation will provide meals, lodging and fuel money but that she is requesting that the Tribe provide a van type vehilce to transport the Apache youth cultural group to Peach Springs during, May 25-27 and to the Phoenix Area during June 23-24, 1990; and
- WHEREAS, the Tribal Council is of the opinion that the cultural exchange with the Choctaw Indian Tribe and the cross-cultural festival involving the Hopi, San Carlos and Gila River Tribes and others at Peach Springs and Phoenix will contribute to the preservation of Apache customs and traditions.

Resolution No. 05-90-98

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby recognizes the Apache youth who will attend the summer youth cultural exchange pow-wow and conference on the Choctaw Indian Reservation in Mississippi as ambassadors of goodwill and Apache culture for the White Mountain Apache Tribe.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Tribal Chairman to present a gift on behalf of the White Mountain Apache Tribe to Chief Phillip Martin of the Choctaw Indian Tribe to be presented to him by Apache youth during the cultural exchange July 5-18, 1990 on the Choctaw Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Tribal Chairman to appropriate for use by the White Mountain Apache Save the Children Federation cultural group, a tribal van type vehicle as transportation to the Hualapai Indian Reservation to attend the Peach Springs Festival May 25-27, 1990 and to attend cultural activities at the Gila River Cultural Center and Heard Museum on June 23-24, 1990.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby extends its appreciation to the Apache youth attending these festivals for their interest and dedication to preserving traditional Apache values.

The foregoing resolution was on May 16, 1990, duly adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (g) (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
