

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council is charged with the constitutional duty to manage all tribal lands and natural resources of the White Mountain Apache Tribe; and

WHEREAS, the preservation and careful development of natural resources is a responsibility of grave importance to future Apache generations; and

WHEREAS, the appointment of a Natural Resource Committee comprised of professionals and public spirited citizens of the tribe who are concerned with the preservation and sound management of the tribe's natural resources can greatly assist the Tribal Council in carrying out its constitutional responsibility to preserve and regulate the development of natural resources on the reservation for the benefit of tribal people; and

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints the following persons as members of the Natural Resource Committee:


