

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council by Resolution No. 12-90-275, gave final approval to the White Mountain Apache Bingo and Gaming Ordinance No. 164; and

WHEREAS, the Bureau of Indian Affairs has advised that the resolution was not delivered to the Bureau within the 10 days as required by the Tribal Constitution; and

WHEREAS, the Tribal Council wishes to reaffirm final approval of the White Mountain Apache Bingo and Gaming Ordinance No. 164 this date.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby reaffirms it's final approval of the White Mountain Apache Bingo and Gaming Ordinance No. 164, in the form and content attached to prior Resolution No. 12-90-275, passed on December 6, 1990.

The foregoing resolution was on December 19, 1990, duly adopted by a vote of six for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (a) (g) (i) (u) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Signatures of the members of the Tribal Council represent their approval of Tribal Resolution No. 12-90-290.
