BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the Tribal Relinquishment Request of Gregory Lon Kane, and his tribal membership with the White Mountain Apache Tribe is granted relinquished this date.

The foregoing resolution was on June 19, 1991, duly adopted by a vote of <u>five</u> for and <u>one</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article III, Section 3 of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
