RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, District III Councilmember Randall Massey, Jr. has requested on behalf of the East Fork Community authorization from the Tribal Council to expend East Fork Land Claims Funds in the amount of \$600.00 for the purchase of uniforms for the East Fork Basketball Team and has presented a petition from the Community in support thereof and attached hereto; and
- WHEREAS, Councilmember Randall Massey further requests on behalf of the community, authorization to expend \$500.00 for food for Thanksgiving, \$500.00 for food for Christmas and an additional \$500.00 for gift exchange for Christmas 1991 from the East Fork Community Land Claim Fund; and
- WHEREAS, the Tribal Council concludes that permission should be granted; and
- WHEREAS, Councilmember Randall Massey, Jr. acknowledges concerns from BIA Tribal Operations Officer, Dallas Massey, that said funds should be utilized in conformity with the distribution formula of 22-D which requires that monies be expended for recreational purposes.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the expenditure of not more than \$600.00 from the East Fork Community Land Claims Fund for the purchase of uniforms for the East Fork Community Basketball Team.
- BE IT FURTHER RESOLVED by the Tribal Council that it further authorizes the East Fork community to expend from its land claims fund, \$500.00 for Thanksgiving food, \$500.00 for Christmas food, and \$500.00 for Christmas gifts.
- BE IT FURTHER RESOLVED by the Tribal Council that it reminds the East Fork Community that the East Fork Land Claims Fund is for recreational purposes and uses.

The foregoing resolution was on November 13, 1991, duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
