

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council of the White Mountain Apache Tribe by previous resolution endorsed and initiated the Title VI program under the Older Americans Act; and

WHEREAS, it is the intention of the Tribal Council to continue to endorse the Title VI program in order to promote the delivery of nutritional and supportive services to Indians aged sixty (60) and older in the Whiteriver area; and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe authorizes and supports participation in the Title VI Part A for FY 1992 and FY 1993.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman is authorized and directed to prepare and submit an application and proposal to enter into a contract with the Department of Health and Human Services, Administration on Aging, for tribal administration of the Title VI program under the Older Americans Act in order to promote the delivery of social and nutritional services to Indians aged sixty (60) and older in the Whiteriver area on the Fort Apache Indian Reservation.


BE IT FURTHER RESOLVED by the Tribal Council that the Tribal Chairman, or in his absence, the Vice Chairman, is authorized to sign any and all documents required to consummate this contractual agreement for the Title VI program, and subsequent contractual agreements every year thereafter.


The foregoing walk-thru resolution was on March 17, 1992, duly adopted by a vote of 11 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (b) (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




WHEREAS, the Tribal Council of the White Mountain Apache Tribe enacted a Roads Priority List in Resolution No. 02-92-260 and is advised by Councilmember Frank Endfield, Jr. that McNary streets were not included in said priority list under District IV; and

WHEREAS, Mr. Endfield requests that McNary streets be placed on the priority list under District IV and the Tribal Council agrees with his recommendation.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby amends Resolution No. 02-92-260 to include McNary streets on the priority list under District IV.

BE IT FURTHER RESOLVED by the Tribal Council that all other provisions of Resolution No. 02-92-026 shall remain in full force and effect.
