

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION


- WHEREAS, there is an outstanding bill for fencing in the approximate amount of \$8,939.00 for the Canyon Day Rodeo Arena; and
- WHEREAS, a request has been made that the Tribal Council authorize funding from the General Land Claims Fund to pay for the outstanding bill; and
- WHEREAS, the Tribal Council concludes that the request should be granted provided that the outstanding fencing bill shall be paid from the Canyon Day Community's share of the equal distribution of remaining General Land Claim Funds.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes \$8,939.00 from the Canyon Day Community's equal share of remaining General Land Claims Fund for the purpose of paying the outstanding fencing bill to the vendor identified therein.

The foregoing resolution was on March 18, 1992, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

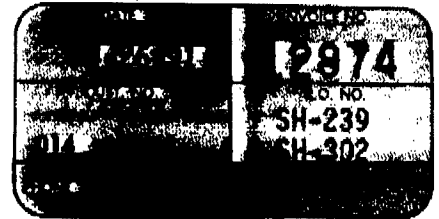
