


**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

- WHEREAS,** tribal member, Mary Jane Carter, who is presently renting a house in McNary, known as 426 E. Oak Street, has come before the Tribal Council and requested that the house be turned over to her so that she can invest her time, effort and money to renovate the house to make it more suitable for her and her family; and
- WHEREAS,** she advises the Tribal Council that the house was vacant for two years and she has lived there since September, 1991, and that no one else has filed a claim for the house; and
- WHEREAS,** Ms. Carter is advised by the Tribal Council that previous requests for house have been granted at McNary with the understanding that the land underneath the house remains with the Tribe and that no land assignments are being granted for the houses due to future plans for commercial development of the area; and
- WHEREAS,** Ms. Carter acknowledges that information from the Tribal Council; and
- WHEREAS,** the Tribal Council concludes that Mary Jane Carter should be given the rental house at 426 E. Oak Street and that the entire responsibility for maintenance and repairs shall be hers and that the house should be taken off the McNary Housing Authority rental unit list.
- BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby donates the house located at 426 E. Oak Street to Mary Jane Carter as her personal property.
- BE IT FURTHER RESOLVED** by the Tribal Council that it hereby directs that no land assignment be made for the land upon which the house presently stands until further notice by the Tribal Council as lands comprising the McNary townsite and land adjacent thereto have been designated as a commercial development area.
- BE IT FURTHER RESOLVED** by the Tribal Council that it hereby directs McNary Housing Authority Director, Matthew Hinton, to remove 426 E. Oak Street from the Tribal Housing rental list, and that the Legal Department prepare the necessary Bill of Sale or appropriate legal document to evidence that title to 426 E. Oak Street has been transferred to Mary Jane Carter

The foregoing resolution was on April 08, 1992, duly adopted by a vote of seven for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (h) (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
