


**RESOLUTION OF THE

FORT APACHE INDIAN RESERVATION**

WHEREAS, Raymus Albert, Director of Tribal Land Office, has come before the Tribal Council requesting approval of land board meeting minutes of May 8, 1992 and June 12, 1992; and

WHEREAS, the Tribal Council has reviewed said land board meeting minutes and is in agreement that said minutes should be approved as written.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the land board meeting minutes of May 8, 1992 and June 12, 1992 as attached.

The foregoing resolution was on July 09, 1992, duly adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (h) (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

LAND BOARD MEETING

May 8, 1992

A regularly scheduled Land Board Meeting was held on May 8, 1992 in the Tribal Council Chambers. Members present were Slim Quay, Lula Ann Ivins, Sidney Baha and Esther T. Lupe. Edward Walker was absent. The meeting opened at 9:00 a.m.

Ula Adley requested a homesite north of Willie Nozie's residence. South of main road and west side of Willie Road. This was approved by the Land Board.

Genevieve Palmer requested to have K. Quintero move fence back to old fence line. She said this land was given to her by the Land Board when she got the house. The Board will write a letter to K. Quintero to move the fence back.

Marie T. Alsenay - Homesite at Cibecue where she has lived for 23 1/2 years and she doesn't want to give it up. This land was sold to Francis Alsenay in July 1966 by the family. This is where they build their house and farm for 23 years and now Isabelle T. Mason want the land back because someone had ask her to do so. This will be discussed later with Francis Alsenay being present because he is the one who got this farmland No. 37, Farmer Ditch.

Rowena R. Daniels her mother Beatrice R. Zahgotah, relinquished her farmland to Rowena. Farm #2 1.96 Ac. on Kaytoggy Ditch, North Fork.

Gina Webster requested a homesite in Lakeside area, she needs to get Livestock approval from Ceder Creek.

Manuel Dazen ask about his homesite application at Cedar Creek; to check at office later.

Michael Fall, Sr. requested homesite at North Fork was denied, the area has been assigned to Alida Antonio.

Ray Antonio, practice area at Canyon Day next to his house. Denied this will be checked out by survey crew.

Linda Burnette homesite at Ft. Apache. Denied belongs to Theodore Roosevelt School.

June 12, 1992

A regularly scheduled Land Board Meeting was held on June 12, 1992 in the Tribal Council Chambers. Members present were Slim Quay, Lula Ann Ivins, Sidney Baha and Esther T. Lupe. Edward Walker was absent. The meeting opened at 9:25 a.m.

Loretta Dazen came and said she wanted the land that was approved for Rusty Cosay. It was lended out to him and not given to him. A meeting will be held on this for both parties, 2 weeks from today.

Manuel Dazen's homesite application was approved for a site in Cedar Creek.

Manuel Dazen farmland relinquishment from Loretta Dazen, tabled until the next meeting.

Lynn Cody requested a farmland in Carrizo. He was told to get a Livestock approval first, his application was approved.

Dorothea Truax application for a homesite in Carrizo was approved.

Lizzie Altaha requested to move the road that goes through her farmland in Carrizo. Leonard Alchesay also requested to move the road. A special meeting will be held on this, the Board will go to the farmland.

Also invite to the next meeting. Close the graveyard and leave it for farming only.
