- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the request of Theresa Pearl Shaw that her tribal membership with the White Mountain Apache Tribe be relinquished this date.

The foregoing resolution was on <u>July 09, 1992</u>, duly adopted by a vote of <u>nine</u> for and <u>zero</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article III, Section 3 of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Further, I realize that I will no longer have fishing or hunting privileges on the Fort Apache Indian Reservation; no homesite or farmland assignments, or claim to have title to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act.
