

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

- WHEREAS,** the Federal Intermodal Surface Transportation Act of 1991 (ISTEA) provides significant money for road construction on Indian Reservations; and
- WHEREAS,** Bureau of Indian Affairs has been designated as the agency to administer these funds for Tribes; and
- WHEREAS,** the Roads Department of the Bureau of Indian Affairs has requested a listing of priorities in road construction desired by the White Mountain Apache Tribe and has requested that it be submitted prior to August 15, 1992; and
- WHEREAS,** the White Mountain Apache Tribe wants to utilize as much of the money allocated to it for road purposes as possible, there being a great need for road construction on the reservation; and
- WHEREAS,** the Roads Committee and the Tribal Council of the White Mountain Apache Tribe have discussed a priority list for BIA road construction within the Fort Apache Indian Reservation; and
- WHEREAS,** the following list comprises the order of preference and priority for BIA road construction on the reservation:





The foregoing resolution was on July 21, 1992, duly adopted by a vote of seven for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
