


**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

- WHEREAS,** the Tribal Council by previous resolution directed the Tribal Council Secretary to post the proposed amendments to Section 2.27 A. of the Judicial Code, to provide that attorneys employed by the Fort Apache Legal Aid shall be granted a license to practice law before the White Mountain Apache Tribal Court, in each district for a minimum of 10 days as required by the Constitution; and
- WHEREAS,** the Tribal Council Secretary advised the Tribal Council that said proposed ordinance has been posted in accordance with that directive; and
- WHEREAS,** the Tribal Council having received no opposition to the proposed ordinance concludes that the ordinance should be enacted in the interest of obtaining justice and representation for tribal members.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby enacts the attached Ordinance No. 180 amending Section 2.27 A. of the Judicial Code of the White Mountain Apache Tribe.

The foregoing resolution was on August 28, 1992, duly adopted by a vote of five for and one against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (q) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

ORDINANCE OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

BE IT ENACTED by the White Mountain Apache Tribal Council in Council assembled that Chapter Two, Section 2.27 A. of the Judicial Code of the White Mountain Apache Tribe is hereby amended as follows:

SECTION 2.27 LICENSES TO PRACTICE LAW; FEES; ROLE OF COUNSEL; STANDARDS OF CONDUCT

A. Attorneys: No non-member attorney shall be granted a license to practice law before the White Mountain Apache Tribal Court unless he or she is an attorney in good standing, licensed and a member of the State Bar of Arizona, provided that this rule shall not impair the ability of an attorney to practice before the White Mountain Apache Tribe if he or she is **employed as an attorney by the Fort Apache Legal Aid**, or is admitted to practice in the state of Arizona pursuant to Rule 33(3) [full-time law school faculty] Rule 38 (d) & () [clinical law school professors and law students], and Rule 40 [attorneys working full-time for approved legal services organizations], Rules of the Supreme Court of Arizona.

The foregoing Ordinance was on August 28, 1992, duly adopted by a vote of five for and one against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (q) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958 pursuant to Section 16 of the Act of June 18, 1983 (48 Stat. 984).
