


**RESOLUTION OF THE

**WHEREAS,** the Tribal Council has reviewed said land board meeting minutes and is in agreement that said minutes should be approved with one correction, the deletion of Line No. 6 under FARMLAND APPLICATIONS APPROVED.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the land board meeting minutes of August 14, 1992 with one correction.

The foregoing resolution was on September 10, 1992, duly adopted by a vote of seven for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (h) (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
