RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, Doctor Joseph Landovazo, Superintendent of the Whiteriver School District No. 20 has come before the Tribal Council with a request that the Tribal Council grant a license or permission for the Whiteriver School District to operate a Daycare Center restricted to students attending Alchesay High School; and
- WHEREAS, the Tribal Council has no objection to the Whiteriver School District No. 20 operating a Daycare Center for Alchesay High School students so that students who are also parents may be able to complete their high school education; and
- whereas, the Tribal Council advises Superintendent Landovazo that although it is waiving any objection to the operation of a Daycare Center at Alchesay High School, such waiver does not constitute the act of licensing by the Tribal Council of a Daycare Center; and
- WHEREAS, any Daycare Center operated by the Whiteriver School District No. 20 should comply with applicable rules and regulations pertaining to Daycare Centers.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby waives any objection to the Whiteriver School District No. 20 operating a Daycare Center at the Alchesay High School.
- BE IT FURTHER RESOLVED by the Tribal Council that its waiver of any objection to the operation of a Daycare Center at the Alchesay High School does not create any responsibility or duty upon the Tribal Council to license or monitor the operation of the Daycare Center or to be liable in any way whatsoever for the operation or administration of the Daycare Center, that being the sole responsibility of the Whiteriver School District No. 20; nor does it constitute abrogation of the Tribal Councils sovereign right to, in the future, to license, monitor and regulate Daycare Centers on the Fort Apache Indian Reservation.
- BE IT FURTHER RESOLVED by the Tribal Council that it extends its appreciation to Dr. Landovazo for taking the time and effort to establish a Daycare Center at the high school for the welfare and benefit of student-parents who wish to complete their high school education.

The foregoing resolution was on October 14, 1992, duly adopted by a vote of seven for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
