- WHEREAS, the Tribal Council by previous resolution approved the tribal constitution revision and appropriated monies for Phase 1 of said plan; and
- WHEREAS, the Tribal Council is advised that Phase 1 of the constitution revision plan is completed and the Constitution Committee is requesting funding for completion of the project; and
- whereas, the Tribal Council concludes that tribal monies should be appropriated for the purposes of completing the Constitution Revision Project as set forth in the budget attached to this resolution and by reference made a part hereof.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby appropriates an amount not to exceed \$18,350 from the Tribal Contingency Funds to complete the Constitution Revision Project to be expended pursuant to the budget attached hereto.

The foregoing resolution was on <u>January 06, 1993</u>, duly adopted by a vote of <u>seven</u> for and <u>zero</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (a) (b) (k) (s) (u) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
