

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council recognizes the need to provide clean and safe facilities for the boarding students at the Theodore Roosevelt Boarding School (TRS), and temporary classroom facilities at the John F. Kennedy Day School (JFK); and

WHEREAS, current facilities at TRS have inadequate fire protection, numerous life safety code violations and an inoperative heating system; and

WHEREAS, repair of the heating system requires extensive asbestos abatement and the cost of bringing the facility to safe level of occupancy for the students cannot be accomplished before the start of the 93-94 school year; and

WHEREAS, classroom facilities at the JFK School are grossly inadequate to house 50-80 students; and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe, the governing body on the Fort Apache Indian Reservation adopted Tribal Resolution No. 08-92-223 requesting the Bureau of Indian Affairs, Office of Indian Education Programs to allocate financial resources to the Fort Apache Office of Indian Education Programs for needed modular/trailer units for temporary classroom facilities at the JFK School; and

WHEREAS, the request for temporary boarding facilities and classroom facilities has been submitted through the proper channels and the Phoenix Area Facility Staff agree that temporary facilities are needed, but are not able to provide the necessary funds for this project.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe hereby request Dr. Eddie F. Brown, Assistant Secretary of Indian Affairs, to authorize the use of Minor Improvement and Repair (MI&R) funds to provide temporary modular/trailer boarding facilities for the Theodore Roosevelt School students prior to the start of the 93-94 school year; and for temporary classroom modular/trailer units at the John F. Kennedy School prior to the start of 93-94 school year.

BE IT FURTHER RESOLVED by the Tribal Council that the Superintendent, Fort Apache Agency and Superintendent for Education, Fort Apache Agency work jointly to acquire necessary portable modular/trailer units and assure such buildings are installed prior to the start of the 93-94 school year.

The foregoing resolution was on June 30, 1993, duly adopted by a vote of five for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
