

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, the Tribal Council has received numerous complaints about the absenteeism of the Adult Tribal Prosecutor due to extensive travel and training workshops the Adult Prosecutor attends or because of other reasons not readily known to the Tribal Council; and

WHEREAS, the Council is advised that cases have been dismissed and many Tribal Members have complained about the lack of attention to their criminal complaints; and

WHEREAS, the Tribal Council based on these reports concludes that it would be in the best interests of the people of the White Mountain Apache Tribe for the Tribal Attorney to supervise the Adult Tribal Prosecutor and that the prosecutor's budget should be transferred to the office of the Tribal Attorney; and

WHEREAS, the Tribal Council further concludes that the Adult Tribal Prosecutor must cease all travel immediately; and

WHEREAS, the Tribal Council further concludes that the Tribal Attorney should evaluate the performance of both the adult and the juvenile prosecutors and should make recommendations concerning both positions and that the juvenile prosecutor also be placed under the supervision of the Tribal Attorney.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby places the Tribal Adult Prosecutor and Tribal Juvenile Prosecutor under the supervision of the Tribal Attorney's office.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the Tribal Attorney to evaluate both the Adult and Juvenile Prosecutor positions and performance to date.

BE IT FURTHER RESOLVED by the Tribal Council that the Adult Tribal Prosecutor is directed to cease all off-reservation travel and workshops until further notice.

BE IT FURTHER RESOLVED by the Tribal Council that the budget allocation for the Adult Tribal Prosecutor is hereby transferred to the office of the Tribal Attorney.


Resolution No. 07-93-200
