RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council has previously discussed with the Bureau of Indian Affairs the necessity for an airport in the Cibecue community for purposes of providing greater access by the Bureau of Indian Affairs to fulfill Bureau responsibilities as well as providing ready access for emergency medical services to the area; and
- whereas, the Bureau of Indian Affairs has prepared a legal description for the proposed Cibecue Airport Compound comprised of approximately 130.427 acres, a copy of which is attached to this Resolution and incorporated by reference herein; and
- whereas, the Tribal Council wishes to reserve said land for use as the Cibecue Airport Compound pending further discussions with livestock associations and the Land Board.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby reserves for the Cibecue Airport Compound Project a land area containing 130.427 acres, more or less, in accordance with the legal description attached to this Resolution and incorporated by reference herein.
- BE IT FURTHER RESOLVED by the Tribal Council that a permanent assignment of said land for the Cibecue Airport Compound shall be subject to consultation with livestock associations and the Land Board to determine the impact on both.

The foregoing resolution was on <u>July 14, 1993</u>, duly adopted by a vote of <u>three</u> for and <u>zero</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) (h) (t) (u) of the Amended Constitution and By-laws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 State. 984).
