

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, pursuant to a Secretarial Election authorized by the Secretary of the Interior on June 15, 1993, the attached Constitution of the White Mountain Apache Tribe of Arizona was submitted to the qualified voters of the Tribe and on September 30, 1993 was duly adopted by a vote of 827 for and 531 against and 13 cast ballots found spoiled or mutilated in an election in which at least 30% of the member entitled to vote, cast their ballots in accordance with 25 C.F.R. Section 81, as certified by the Superintendent of the Fort Apache Agency and Election Board, a copy of which is attached to this Resolution; and

WHEREAS, the Tribal Council as the governing body of the White Mountain Apache Tribe has reviewed the Certificate of Results of the Secretarial Election on the Tribe's Constitution which took place September 30, 1993; and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe concludes that the Certificate of the Results of the Election on the attached Constitution of the White Mountain Apache Tribe of Arizona should be accepted and approved.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby accepts and approves the Certificate of Results of the election for the Secretarial Election for the White Mountain Apache Tribe held on September 30, 1993 as attached to this Resolution and incorporated by refernce herein.

The foregoing resolution was on October 01, 1993, duly adopted by a vote of seven for and three against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (a) (i) (s) (u) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
