

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, Ben Little, Sr. and Ida (Declay) Little request that their children's Paula Ranae Little and Crista Lee Little, tribal membership with the White Mountain Apache Tribe be relinquished so that they will become eligible for enrollment with the Navajo Tribe; and

WHEREAS, the necessary documents of relinquishment of headrights have been read and signed by the parents, Ben Little and Ida (Declay) Little, in the presence of a Notary Public on the 24th day of June, 1993 and are attached hereto.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the relinquishment of Paula Ranae Little and Crista Lee Little as a member of the White Mountain Apache Tribe, as requested by their parents Ben Little and Ida (Declay) Little.

The foregoing resolution was on October 20, 1993, duly adopted by a vote of six for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article III, Section 3 of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Further, I/We realize that my/our child will no longer have fishing or hunting privileges on the FORT APACHE INDIAN RESERVATION; No homesite or farmland assignments, or claim to have titles to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act. Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the Resolution date accepting my/our child's relinquishment, any livestock in said child's name. I further understand, however, that my child may reapply for enrollment in the White Mountain Apache Tribe upon reaching the age of eighteen (18), but that the Tribal Council has total, nonreviewable discretion to deny or grant said reapplication.
