WHEREAS, Raymus Albert, Director of Tribal Land Office, has come before the Tribal Council requesting approval of land board meeting minutes of October 29, 1993; and

WHEREAS, the Tribal Council has reviewed the land board meeting minutes and is in agreement that the minutes should be approved with a request to table land assignment for Bryant Keith Cosen for one month.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the land board meeting minutes of October 29, 1993 with the exception of Bryant Keith Cosen whose land assignment has been tabled for one month.

The foregoing resolution was on November 04, 1993, duly adopted by a vote of six for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (h) (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
