

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

WHEREAS, Article VI of the Tribal Constitution of the White Mountain Apache Tribe requires regular elections to be held for Tribal Council Members; and

WHEREAS, pursuant to Article VI, Section 8 of the Tribal Constitution, the Tribal Council adopted an Election Ordinance which mandates that the General Election be held on the first Wednesday of April during an election year, established by Article VI, Section 1 of the Tribal Constitution; and

WHEREAS, said Election was held by the White Mountain Apache Tribe on Wednesday, April 6, 1994, where those Tribal Council candidates who were certified to the Tribal Council on February 3, 1994 after the Primary Election submitted their names to a vote of the people for Chairman and Vice-Chairman and for Council Offices in Districts I, II, III and IV; and

WHEREAS, the Tribal Election Commission has certified to the Tribal Council of the White Mountain Apache Tribe the General Election Results pursuant to Section 3.6.15 F. of the Tribal Government Code and that the election is complete and has been carried out in accordance with provisions of the Tribal Constitution and Chapter 3 of the Government Code of the White Mountain Apache Tribe and has certified that the reservation-wide votes cast totaled 4,523 votes, and that the following number of votes were received by the individuals listed below whose names were on the ballot for the following offices:

WHEREAS, pursuant to Section 3.6.16 A. of the Election Code, an automatic recount was conducted by the Election Commission for District IV Candidates Monical Cromwell and Marvin Ethelbah; and

WHEREAS, prior to the recount taking place, the Election Commission personally contacted Candidates Monical Cromwell and Marvin Ethelbah and invited them to attend and witness the recount; and

WHEREAS, the Election Commission has confirmed from the recount that Marvin Ethelbah received the greatest number of votes and has certified Marvin Ethelbah as the elected candidate for District IV with Johnny Frank Endfield, Jr.; and

WHEREAS, pursuant to section 3.6.15 F. of the Tribal Election Code, the Election Commission has certified that the following candidates received the greatest number of votes and has also certified the following persons as the elected candidates to the Tribal Council:


BE IT FURTHER RESOLVED by the Tribal Council that the Tribal Council positions which were the subject of this election shall be filled as follows:






