

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, it is a requirement of the White Mountain Apache Tribe to have an approved annual budget in place by May 1, 1994 for the new 94/95 fiscal year for all Enterprises and Central Tribe Departments; and

WHEREAS, as of this date the budget for FY 94/95 covering the period from May 1, 1994 through April 30, 1995, has not been reviewed and approved by the Tribal Council due to the recent general election and other activities surrounding the election; and

WHEREAS, pending review and final approval of the FY 94/95 budgets by the Tribal Council it is necessary that the Tribal Council authorize by Resolution a continuation of funding for all Enterprises and Central Tribe Departments pursuant to their respective FY 93/94 annual modified budgets prorated monthly at 1/12 for 60 days or until the Tribal Council approves the new budget; and

WHEREAS, certain expenses require immediate attention and should be exempted from this Resolution as follows:

1. Chairman's Office Capital
2. Vice-Chairman's Office Capital
3. Inauguration Expenses
4. Capital items that are essential for the Day to Day operation and/or maintains the profitability of an Enterprise upon approval of the Chairman.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes continued interim funding for all Tribal Enterprises and Central Tribe Departments for a period of 60 days prorated monthly at 1/12 of their respective FY 93/94 annual modified budget or until the new FY 94/95 budget is approved.

BE IT FURTHER RESOLVED by the Tribal Council that certain expenditures that are outlined above are exempted from this resolution.

BE IT FURTHER RESOLVED by the Tribal Council that all existing budget controls shall remain in full force and effect.

The foregoing resolution was on May 03, 1994, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (i) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Signatures of the members of the Tribal Council represent their approval of Tribal Resolution No. 05-94-111.
