

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, Tribal Council Member Judy DeHose has come before the Tribal Council and has requested that in view of the upcoming Tribal Fair & Rodeo, there is a need to upgrade, repair and refurbish the White Mountain Apache Motel and Restaurant complex; and

WHEREAS, Mrs. DeHose advises the Tribal Council that bathroom tiles, bedding, beds, television sets and other features of the motel are in dire need of repair and that general standards of cleanliness are not being adhered to; and

WHEREAS, Mrs. DeHose requests that the Tribal Council consider approval of capital expenses of \$2,000.00 for new beds, \$7,500 for television sets with HBO capability, \$5,000.00 for repair of bath tiles, baseboards, floors and walls and \$4,000.00 for new chairs for the rooms, as well as upgrading the lobby bathrooms for men and women; and

WHEREAS, the Tribal Council concludes that it would be in the best interest of the Tribe that the requested capital budget be approved and that the repairs, work and clean up be accomplished prior to the upcoming Tribal Fair and Rodeo; and

WHEREAS, the Tribal Council is also advised that the Indian Health Service Environmental Health Department should conduct a health inspection of the restaurant and motel and present a report to the Tribal Council and the Office of the Tribal Chairman.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves a capital expenditure budget for the White Mountain Apache Motel & Restaurant as follows: \$2,000.00 for beds; \$7,500.00 for television sets with HBO capability; \$5,000.00 for repair and replacement of bath tiles, baseboards, walls and floor repair and \$4,000.00 for new chairs for a total of \$18,500.00.


BE IT FURTHER RESOLVED by the Tribal Council that it requests the IHS Environmental Health Department to conduct a sanitary and health inspection of the restaurant and motel and file a report with the Tribal Council and Office of the Tribal Chairman as soon as possible.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the manager of the Whiteriver Commercial Complex to complete the foregoing repairs, clean up and replacement of items as described in this resolution prior to the Tribal Fair & Rodeo

The foregoing resolution was on July 14, 1994, duly adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
