

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, representatives of the Cedar Creek Community have come before the Tribal Council with the request that Cedar Creek Land Claims Fund be authorized by the Tribal Council to finance a Halloween Carnival and to construct a Little League backstop; and

WHEREAS, the Tribal Council is advised that \$600.00 is requested for the Halloween Carnival and \$1,500.00 for the Little League backstop, for a total request of \$2,100.00 from the Cedar Creek Land Claims Fund.

WHEREAS, the Community's representatives further advise the Tribal Council that they will submit an appropriate petition to the Tribal Council Secretary as required by tribal policy; and


WHEREAS, the Tribal Council concurs with the Community's request.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes \$2,100.00 be withdrawn from the Cedar Creek Land Claims Fund for the Halloween Carnival (\$600.00) and the Little League backstop (\$1500.00).

BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the Cedar Creek Community to submit and file the appropriate petition requesting the foregoing expenditure to the Tribal Council Secretary as soon as possible.

The foregoing resolution was on October 05, 1994, duly adopted by a vote of ten for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
