

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**WHEREAS,** a petition has been filed and received by the Council Secretary, on behalf of the residents of Carrizo requesting that their community's Land Claim Funds be utilized so that they can sponsor a Halloween Carnival; and

**WHEREAS,** the Tribal Council is advised that Carrizo Community is requesting \$500.00 from their community Land Claim funds for that purpose; and


**WHEREAS,** the Tribal Council is advised that Carrizo Land Claim funds have sufficient monies to grant this request.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes use of \$500.00 from Carrizo Land Claim funds, so that the Carrizo Community can sponsor a Halloween Carnival for the community.

The foregoing resolution was on October 18, 1994, duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (i) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Signatures of the members of the Tribal Council represent their approval of Tribal Resolution No. 10-94-324.




