

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, the Tribal Council has traditionally purchased Christmas candy with the General Land Claims funds for distribution in each district on the Fort Apache Indian Reservation; and

WHEREAS, District III Councilmembers have requested by petition attached herein to utilize East Fork and Seven Mile Land Claims fund to sponsor a Christmas party which will also include Christmas candy distribution; and

WHEREAS, a total of 8,000 sacks of Christmas candy will be distributed in Districts I, II and IV communities on the Fort Apache Indian Reservation; and

WHEREAS, the total cost for 8,000 sacks of Christmas candy for Districts I, II and IV will be paid for by the General Land Claims fund; and


WHEREAS, Christmas parties and candy distribution for District III will be paid for by East Fork and Seven Mile Land Claims fund.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the use of General Tribal Land Claims fund for the purchase of 8,000 sacks of Christmas candy for communities in Districts I, II and IV.

BE IT FURTHER RESOLVED by the Tribal Council that \$1,800.00 for Christmas parties and candy distribution for District III will be paid for from East Fork and Seven Mile Land Claims fund.

The foregoing resolution was on December 05, 1994, duly adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (i) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
