WHEREAS, McNary Community President, Fernando Carroll requested that McNary Land Claims Fund be authorized by the Tribal Council to finance their annual clean-up/recreation activities scheduled for May 06, 1995; and

WHEREAS, the Tribal Council is advised that \$250.00 is requested for the clean-up/recreation activities from the McNary Land Claims Fund; and

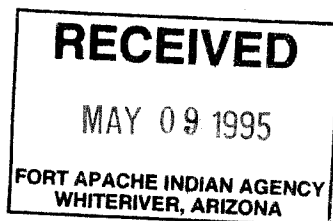
WHEREAS, Mr. Carroll further advise the Tribal Council that they will submit an appropriate petition to the Tribal Council Secretary as required by tribal policy; and


WHEREAS, the Tribal Council concurs with the Community's request.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes \$250.00 be withdrawn from the McNary Land Claims fund for clean-up/recreation activities scheduled for May 06, 1995.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the McNary Community to submit and file the appropriate petition requesting the foregoing expenditure to the Tribal Council Secretary as soon as possible.

The foregoing resolution was on May 03, 1995, duly adopted by a vote of ten for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
