

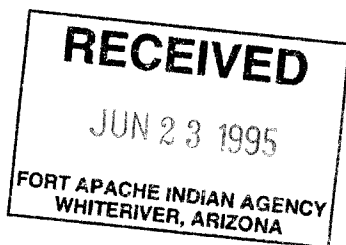
**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**


**WHEREAS**, Slim Quay, Committee member for the Tribal Land Office, has come before the Tribal Council requesting approval of land board meeting minutes of March 10, 1995; and


**WHEREAS**, the Tribal Council has reviewed the land board meeting minutes and is in agreement that the minutes should be approved without change.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the land board meeting minutes of March 10, 1995 as presented.

The foregoing resolution was on June 09, 1995, duly adopted by a vote of seven for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (h), (i), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

LAND BOARD MEETING

A monthly land board meeting was held on March 10, 1995 in the Tribal Council Chambers. Members present were Slim Quay, Lula Ann Ivins and Esther T. Lupe. The meeting opened at 9:30 a.m.

Henry Haven came requesting that a survey be done on his farm land in C.B.Q. due to the Lutheran Church taking up space on his farm land. He also came to Renew his application. Farm Land application was approved.

Juan Antonio request farmland be put in his name in Cedar Creek, which use to belong to his Aunt Genie Paxson. The farm land is located next to the Cedar Creek Rodeo Grounds. The board request that Raymus check this location out and see who's name is on the land. A letter will be sent out to Juan letting him ~~now~~ know the out come regarding the farm land.

Virgil Paxson request land out in McNary for a homesite and pasture. Livestock has already approved of his application. The board put his application on hold to have Raymus look at the area and see how many acres Virgil is requesting.

Samuel Holden request that his homesite application be approved. McDaniel will check out area at Land Office and to check homesite file for ~~Agnes~~ Agnes Holden and Lucky Holden.

Eva & Paulita ~~Penal~~ <sup>Dinal Agnes</sup> came to the meeting to request the farm land of the late Roy Alchesay in North Fork. They were told to check with Raymus.

Ruth ~~Dokashay~~ <sup>Dahkoshay</sup> request a homesite in Whiskey Flats. She already has land down below Whiteriver on River Road, but she doesn't want that land due to area being flooded during ~~the raining~~ the rainy season. Her homesite application was approved.

Fannie Bread request a homesite in six pack she ~~was~~ given an application to fill out and sent over to Land Office to pick out a homesite. She request a site by ~~Erin~~ <sup>Colin</sup> Walker and her relinquishment to Dee Ann Wallen was also approved.

Simmons Altaha farmland approved for R-14, he has put up a fence in 1945 and he moved out of there in 1948 and he wants to go back there and put up the fence that fell down. His application was approved.

Dave Williams request land in Whiteriver, he will go out with McDaniel to pick out homesite, board approved his application. He will look at available homesite today 3/10/95 at 1:30 p.m.

Ronald Larzelere requested a homesite and horse pasture west of drainage, the area belongs to the TRS School. Request land in Ft. Apache up to the BIA fence line next to the Lutheran Church. His application was approved for homesite and horse pasture.

Cecelia Alchesay relinquished her house to her son's Daryle and Jimmy Antonio in Diamond Creek. She is applying for a homesite in which she has already turned in a relinquishment from which was given to Raymus and will be taken to the next meeting. So her application is put on hold until the next meeting in April.

Cora <sup>Duryea</sup> ~~Durya~~ requested her name be placed on a farm land in East Fork. She was told by the board to fill out a Farm Land Application and draw the area she is interested in and bring it back to the Land Office and it will be presented at the next land board meeting.

Lula Ann requested that McDaniel check out her fence line because she is planning on moving her fence line towards the road due to the horses eating the apples on the apple tree there. McDaniel will go out and check area being fenced in.
