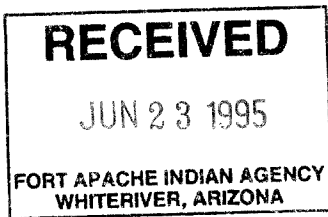


**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**


- WHEREAS**, the Primary Management Official of the Hon-Dah Casino, Micheal Lauf, and Manager of the Hon-Dah Convenience Store, Pearl Fox, have come before the Tribal Council with the request that the liquor license for the Hon-Dah Convenience Store be re-activated for the sale of beer only; and
- WHEREAS**, the Tribal Council is advised that fishermen and other patrons of the Tribe's recreational lakes and rivers have consistently requested that the Hon-Dah Convenience Store re-activate the sale of beer at the store as has been previously done for almost thirty years; and
- WHEREAS**, the license was placed on inactive status during the demolition of the old Hon-Dah Store and construction of the new store; and
- WHEREAS**, Ms. Fox and Mr. Lauf advise the Tribal Council that beer will not be permitted within the Casino and that Casino Security will strictly enforce the prohibition against any open containers within the environs of the Hon-Dah Casino and Convenience Store, including its adjacent parking lots; and
- WHEREAS**, the Tribal Council is further advised that substantial revenues of approximately \$7,000 per month are being lost because beer is not offered for sale to fishermen and other tourists; and
- WHEREAS**, the Tribal Council is assured that the Casino security force and management will ensure that there be no abuses or open containers permitted within the environs and parking lot of the Hon-Dah Casino -- Convenience Store Complex and that, therefore, the license should be activated for the Convenience Store for the sale of beer only.
- BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes and directs Primary Management Official Mike Lauf and Hon-Dah Convenience Store Manager Pearl Fox to immediately reactivate the package liquor store license for the Hon-Dah Convenience Store, provided that beer only be sold and that the casino security force strictly enforce the prohibition against any open containers within the parking lot and environs of the Hon-Dah Casino -
- Convenience Store Complex.

The foregoing resolution was on June 09, 1995, duly adopted by a vote of eight for and two against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (i), (q), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
