

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**WHEREAS**, the Tribal Council previously adopted Resolution 06-95-201 on June 8, 1995 approving and accepting portable classrooms for the Theodore Roosevelt School from the Bureau of Indian Affairs and further authorizing and approving a PL 93-638 procurement contract between the Bureau of Indian Affairs and the Theodore Roosevelt School Board; and

**WHEREAS**, the Tribal Council is advised by the Bureau of Indian Affairs that the Theodore Roosevelt School Board does not have in place the administrative and infrastructure capacity to administer the contract and recommends that the Tribe which has the experience to administer 638 contracts enter into a 638 procurement contract with the Bureau of Indian Affairs in substitution for the Theodore Roosevelt School Board; and

**WHEREAS**, the Tribal Council concurs in this recommendation.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby agrees to enter into a 638 contract for the procurement of portable classrooms for the Theodore Roosevelt School, said classrooms to be purchased with an \$800,000 allocation from the Bureau of Indian Affairs.


**BE IT FURTHER RESOLVED** by the Tribal Council that it hereby reaffirms Resolution 06-95-201 whereby the Tribal Council accepted the portable classrooms for the Theodore Roosevelt School and agreed to maintain said classrooms provided that the BIA transferred sufficient operation and maintenance funds to the Tribe for said purpose and further reaffirms every other provision in Resolution 06-95-201, except as specifically amended herein.

**BE IT FURTHER RESOLVED** by the Tribal Council that the Tribal Chairman, and in his absence the Vice-Chairman, is hereby authorized and directed to execute any and all documents required for the implementation of a 638 agreement with the Bureau of Indian Affairs for the procurement of the portable classrooms for the Theodore Roosevelt School.

The foregoing resolution was on July 06, 1995, duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (j), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
