

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, Councilman Johnny Endfield has brought the Council's attention a petition from District IV eligible voters requesting that funds be authorized by the Council from the District IV Land Claims Account to sponsor a benefit junior rodeo; and

WHEREAS, the amount requested to sponsor the rodeo is \$1,000 and the rodeo is now scheduled for July 8, 1995 in Canyon Day as a fund raiser for two babies, Shadie Hill and Deona Hinton, who recently underwent bone marrow transplants; and

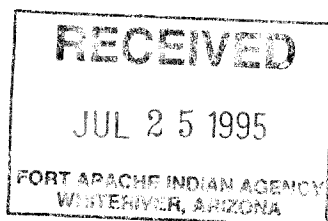
WHEREAS, the families of these two children have suffered a great deal of financial expense during the transplant operations as they were required to reside with their children in California for several months and must schedule future doctor's visits to Phoenix; and

WHEREAS, the Council has been presented with a copy of the petition signed by District IV eligible voters requesting the \$1,000, a copy of which is attached hereto; and


WHEREAS, the Tribal Council concurs with the request.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the sum of \$1,000 to be withdrawn from the District IV Land Claims Account for the purpose of sponsoring a benefit rodeo for the families of tribal children Shadie hill and Deona Hinton.

The foregoing resolution was on July 06, 1995, duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (i), (s), (t), (u) and (k) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
