

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, the representatives of the McNary Community have come before the Tribal Council this date with several requests; and

WHEREAS, the first request is that the Tribal Council approve expenditures from the Land Claims Fund for McNary in the amount of \$8,640 to fund construction of a lighted basketball court in McNary; and

WHEREAS, it is not clear that there are sufficient funds in the McNary Land Claims account to fund a basketball court; and

WHEREAS, the McNary representatives are also concerned about the inadequacy of fire protection for the town of McNary and explain to the Council that during the winter months, the fire trucks cannot make the hill from the fire station to the Town of McNary, and that McNary would benefit if the Tribe would enter into a mutual help agreement with the Pinetop Fire Department to ensure adequate fire protection for McNary residents; and

WHEREAS, the Tribal Council is in support of mutual help agreements with outside fire departments so that all communities, both reservation and non-reservation, can benefit from tribal and non-tribal fire protection departments; and

WHEREAS, tribal member Matthew Hinton, a resident of McNary, has requested permission from the Tribal Council to remove two small buildings from the McNary Sawmill site, copies of photos of which are attached to this resolution, for use as a workshop to repair motor vehicles; and

WHEREAS, the Tribal Council wishes to grant the foregoing requests.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the request of the McNary Community to utilize \$8,640 from the McNary Land Claims account for construction of a lighted basketball court.

BE IT FURTHER RESOLVED by the Tribal Council that in the event there are insufficient McNary land claim funds to finance construction of the lighted basketball court, that the tribal treasurer, Edwin Kane, seek other funding for construction of the basketball court.


BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the tribal treasurer and Dallas Massey of the Bureau of Indian Affairs Tribal Government Operations office, to report the status of all 22-D Land Claim funds at the next regular Tribal Council meeting.


BE IT FURTHER RESOLVED by the Tribal Council that it hereby requests the Tribal Legal Department and the Tribal Fire Department to pursue a mutual help agreement with the Pinetop Fire Department.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby authorizes tribal member, Matthew Hinton of McNary to remove two small buildings from the McNary Sawmill site for the purpose of providing a workshop to repair motor vehicles at his home, provided, that Mr. Hinton shall be solely responsible and shall assume the risk of any injury to himself or any workers employed by him or assisting him during the process of removal of the buildings from the McNary Sawmill site, including transportation of same to the townsite of McNary for Mr. Hinton's use.

The foregoing resolution was on August 2, 1995, duly adopted by a vote of TEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
