

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

- WHEREAS,** the Tribal Council previously reviewed a proposed ordinance establishing Chapter Two of the Environmental Code providing for the regulation of solid waste and landfills on the Fort Apache Indian Reservation; and
- WHEREAS,** the Tribal Council, by Resolution No. 01-95-018, directed the Tribal Environmental Planner and the Office of the Tribal Attorney, to submit a formal "Treatment as a State" or "Tribal Authorization" application to the U.S. Environmental Protection Agency for its comments and to make necessary changes to the proposed ordinance for reconsideration by the Tribal Council; and
- WHEREAS,** the Tribal Environmental Planner and the Office of the Tribal Attorney have complied with that directive and have received comments from U.S. EPA and have addressed all aspects of those comments with U.S. EPA; and
- WHEREAS,** the Tribal Council is now advised that certain changes have been made in response to those comments and the Tribal Environmental Planner and Office of the Tribal Attorney now present the Tribal Council with a revised Tribal Solid Waste Ordinance reflecting those comments and changes, among other things; and
- WHEREAS,** the Tribal Council supports those changes made in the proposed Tribal Ordinance and the statements made in Resolution No. 01-95-018, which is attached hereto and hereby incorporated into this Resolution.
- BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Tribal Council Secretary to post the revised proposed ordinance establishing Chapter Two of the Environmental Code of the White Mountain Apache Tribe providing for the regulation of solid waste and landfills on the Fort Apache Indian Reservation in each District for ten days as required by the Constitution.
- BE IT FURTHER RESOLVED** by the Tribal Council that it hereby authorizes the Tribal Environmental Planner to submit the revised Tribal Solid Waste Landfill Ordinance to the U.S. EPA for its final approval.


BE IT FURTHER RESOLVED by the Tribal Council that the acts and deeds of the members of the Tribal Council necessary to carry out the intent and purpose of this resolution be, and the same are hereby ratified, confirmed and adopted as the acts and deeds of the Tribe.

The foregoing resolution was on August 03, 1995, duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (f), (h), (i), (m), (q), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
