

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, tribal member, Eddie Galen Begay, whose birthdate is July 05, 1969, son of Arthur Begay and Kathryn Truax, has requested that his tribal membership with the White Mountain Apache Tribe be relinquished so that he may become eligible for enrollment in the Navajo Tribe; and

WHEREAS, the necessary documents of relinquishment of headrights were read and signed by Eddie and Arthur Begay, in the presence of a Notary Public on the 29th day of May, 1995, and are attached hereto.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the Tribal membership relinquishment request of Eddie Galen Begay, and his tribal membership with the White Mountain Apache Tribe is granted relinquished this date.

The foregoing resolution was on August 03, 1995, duly adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article II Section 3, including, Article IV, Section 1 (i), (q), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

RELINQUISHMENT OF TRIBAL HEADRIGHTS
WHITE MOUNTAIN APACHE TRIBE
FORT APACHE INDIAN RESERVATION

I, Eddie Galen Begay, am an enrolled member of the White Mountain Apache Tribe and a minor who is at least fifteen years of age but less than 18 years of age. I do hereby, of my own free will, voluntarily and with full knowledge of making this decision, request the TRIBAL COUNCIL of the WHITE MOUNTAIN APACHE TRIBE, FORT APACHE INDIAN RESERVATION, WHITERIVER, ARIZONA, to release me from the Tribal Census Rolls of the White Mountain Apache Tribe so I may be able to enroll with the _____

Navajo Tribe

Further, I realize that I will no longer have fishing or hunting privileges on the FORT APACHE INDIAN RESERVATION; No homesite or farmland assignments, or claim to have titles to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act. Further, that I must remove from the Fort Apache Indian Reservation with ninety (90) days after the Resolution date accepting my relinquishment, any enrollment in the White Mountain Apache Tribe upon reaching the age of eighteen (18), but that the Tribal Council has total, non-reviewable discretion to deny or grant my reapplication.

We, the undersigned, have read and understand the above relinquishment statement, and further understand that the Tribal Council of the White Mountain Apache Tribe shall have the authority to deny this relinquishment request should it conclude that relinquishment would not be in the best interest of the minor child.
