

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, Councilman Alvin Declay has brought to the Tribal Council's attention a petition from District III eligible voters requesting that funds be authorized by the Tribal Council from the District III Land Claims Account to purchase softball equipment and turn on the electricity at the East Fork Community Basketball Court; and

WHEREAS, the amount requested to purchase softball equipment and turn on the electricity at the East Fork Community Basketball Court is \$800.00; and

WHEREAS, the Tribal Council has been presented with a copy of the petition signed by District III eligible voters requesting the \$800.00, a copy of which is attached hereto; and

WHEREAS, the Tribal Council concurs with the request.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the sum of \$800.00 to be withdrawn from the District III Land Claims Account for the purpose of purchasing softball equipment and turning on the electricity at the East Fork Community Basketball Court.

The foregoing resolution was on August 03, 1995, duly adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
