


**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

IN REMEMBRANCE OF TRIBAL COUNCIL MEMBER MARVIN ETHELBAH

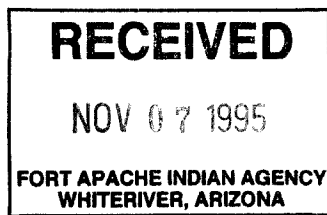
- WHEREAS,** the Tribal Council of the White Mountain Apache Tribe has been advised by the Ethelbah Family that Tribal Council Member Marvin Ethelbah passed away on Tuesday, October 31, 1995, while hospitalized for a heart condition; and
- WHEREAS,** Marvin Ethelbah was recognized by the tribal community as a good husband and father to his eleven children and as an honest and dedicated public servant who spent his life in service to his Tribe, his country, and his community, serving in the U.S. Navy during the Korean War, as a police officer with the Tribal Police Department, as Tribal Chief Judge, and finally as a Tribal Council member representing District IV; and
- WHEREAS,** the Tribal Council is deeply saddened by his passage and wish to pay special tribute to him by designating Monday, November 6, 1995 as a day of mourning and remembrance for him by closing all tribal offices, programs and departments to mark his passage; and
- WHEREAS,** the Tribal Council wishes to acknowledge his devoted and selfless service to the White Mountain Apache Tribe, his constituents, family and friends; and
- WHEREAS,** the Tribal Council, as a tribute to Marvin Ethelbah, wishes to assume all costs of funeral and burial, including a casket, headstone, woodfencing and a flagpole for the gravesite, and a beef for the wake.
- BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby assumes the costs of the funeral and burial for Marvin Ethelbah, including the cost of a casket, headstone, woodfencing around the gravesite, a flagpole and a beef for the wake.
- BE IT FURTHER RESOLVED** by the Tribal Council that in honor of its dearly beloved fellow tribal member and colleague that it hereby orders the closure of all tribal business offices, programs, and departments on Monday, November 06, 1995 as a day of public mourning to mark Marvin Ethelbah's passage from this earthly life to a new life with his Creator.


Resolution No. 11-95-333

The foregoing resolution was on November 03, 1995, duly adopted by a vote of ten for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
