

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**WHEREAS,** the Hon-Dah Casino Primary Management Official, Micheal J. Lauf, has come before the Tribal Council and explained a proposal for the expansion of the Hon-Dah Casino to include a restaurant and lounge; and

**WHEREAS,** Mr. Lauf explains to the Tribal Council that the presently inactive Hon-Dah Restaurant liquor license will expire if not reactivated; and

**WHEREAS,** the Tribal Council is advised that the particular license currently held by the Hon-Dah Restaurant for the past twenty (20) years is a valuable license which ought not to be allowed to terminate; and

**WHEREAS,** Mr. Lauf explains that there have been little or no liquor violations or problems with selling beer at the Hon-Dah Convenience Store to tourists and fishermen, and that the casino security and Tribal Gaming Office personnel have ensured that there are no alcohol related problems within the environs of the casino property; and


**WHEREAS,** Mr. Lauf explains that the restaurant and lounge will provide high quality dinner facilities for casino patrons and persons utilizing the R.V. Center as well as providing a high quality restaurant for persons in the White Mountains, and that no alcoholic beverages will be allowed to be transported by customers from the restaurant lounge area to the gaming portion of the casino; and

**WHEREAS,** the plan is also to provide live entertainment in the restaurant lounge which will add to the overall ambiance and attraction of the Hon-Dah Casino complex; and

**WHEREAS,** the Tribal Council concludes that Mr. Lauf should be permitted to reactivate the liquor license at the restaurant under the conditions that alcoholic beverages will be restricted to the restaurant and lounge area and that the casino will maintain proper security and controls to avoid any potential problems from serving alcoholic beverages in the restaurant and lounge.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves and directs Primary Management Official Micheal J. Lauf to take whatever steps are necessary to reactivate the liquor license at the Hon-Dah Restaurant pursuant to the conditions outlined in this Resolution.

The foregoing resolution was on November 8, 1995 duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (k), (q), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
