

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, the Tribal Council is the governing body of the White Mountain Apache Tribe, and by virtue of the Tribe's inherent sovereignty and additional powers granted to the Tribal Council pursuant to the Tribal Constitution of the White Mountain Apache Tribe, is authorized and empowered to regulate the conduct of Tribal Elections; and

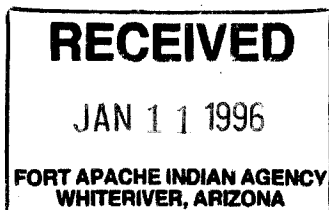
WHEREAS, the Tribal Election Commission has presented for Tribal Council review and approval, a list of Tribal Election Precinct Committee workers for the 1996 Tribal Elections; and


WHEREAS, said proposed list is attached to this Resolution and incorporated by reference herein; and

WHEREAS, the Tribal Council accepts the list as presented, with the exception that the polling place for the Carrizo Precinct shall be the Carrizo Community Building, but if that Community Building is unavailable, the alternate polling place shall be the Assembly of God Church.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the 1996 Tribal Election Precinct Committee workers lists as presented by the Tribal Election Commission in the form attached and incorporated by reference herein.

The foregoing resolution was on December 29, 1995, duly adopted by a vote of Nine for and Zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (i), (s), (t), (u) and (q), and Article VI, Section (8) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 15 of the Act of June 18, 1934 (48 Stat. 984).
