

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, Mr. Larry Bush has come before the Tribal Council with a request that he be permitted to provide a car public car wash service on the premises of the car wash facility at the Whiteriver Commercial Center; and

WHEREAS, Mr. Bush is married to Tribal member Yolanda Colelay Bush and is a resident of Whiteriver; and

WHEREAS, for several years Mr. Bush has provided a variety of cleaning and yard-work services in the Whiteriver area, and he reports that many customers would like to uses his services to have their vehicles cleaned; and

WHEREAS, the Whiteriver Car Wash is currently unused and a car wash business would be beneficial to the Whiteriver community; and

WHEREAS, under his proposal, Mr. Bush would begin with only a modest operation, washing cars by hand, thereby avoiding the need for significant capital investment; and

WHEREAS, at this time the Council shall grant Mr. and Mrs. Bush only a short-term revocable permit to operate as proposed on the premises of the Car Wash; and

WHEREAS, if the business is successful and the Council is satisfied with the services provided by Mr. Bush, the Council may consider a request by Mr. and Mrs. Bush for a longer-term arrangement secured by a leasehold agreement for the Car Wash premises.

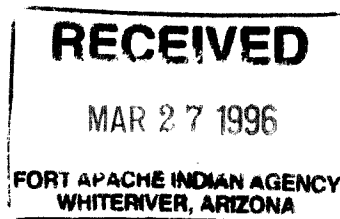
BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves a short-term revocable permit to Mr. and Mrs. Larry Bush to operate a manual car washing and cleaning business on the premises of the Whiteriver Car Wash.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that the term of the permit shall extend for approximately two months, at which time Mr. and Mrs. Bush must return to the Tribal Council to discuss an extension of the permit or the negotiation of a lease agreement with the Tribe.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Tribal Legal Department to draw up the necessary permit form, the terms of which shall be drafted in consultation with the Tribal Controller and that the Council delegates authority to the Tribal Chairman or his designee to execute any documents necessary to carry out the intent of this Resolution.

The foregoing resolution was on March 13, 1996, duly adopted by a vote of seven for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by the White Mountain Apache Tribal Constitution, including Article IV, Sections 1(a), (b), (h), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
