

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, Article VI of the Tribal Constitution of the White Mountain Apache Tribe requires regular elections to be held for Tribal Council Members; and

WHEREAS, pursuant to Article VI, Section 8 of the Tribal Constitution, the Tribal Council adopted an Election Ordinance which mandates that the General Election be held on the first Wednesday of April during an election year, established by Article VI, Section 1 of the Tribal Constitution; and

WHEREAS, said Election was held by the White Mountain Apache Tribe on Wednesday, April 3, 1996, where those Tribal Council candidates who were certified to the Tribal Council on February 8, 1996 after the Primary Election submitted their names to a vote of the people for Council Offices in Districts I, II, III and IV; and

WHEREAS, the Tribal Election Commission has certified to the Tribal Council of the White Mountain Apache Tribe the General Election Results pursuant to Section 3.6.15 F. of the Tribal Government Code that the election is complete and has been carried out in accordance with provisions of the Tribal Constitution and Chapter 3 of the Government Code of the White Mountain Apache Tribe and has certified that of the total reservation-wide votes cast of 3,863 votes, the following number of votes were received by the individuals listed below whose names were on the ballot for the following offices:
