

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**WHEREAS**, the Director of Vital Records, pursuant to Tribal Ordinance Number 59, recommends to the Tribal Council that the individuals listed on the attached list who have applied for membership into the White Mountain Apache Tribe be accepted as members; and

**WHEREAS**, the Director of Vital Records, advises that each person listed on the attached list qualifies for membership pursuant to the Tribal Constitution; and


**WHEREAS**, the Enrollment Committee reviewed the applicants list, and recommends that they be granted enrollment into the White Mountain Apache Tribe; and

**WHEREAS**, the Tribal Council has reviewed the applicants list and concurs with the recommendations that the persons listed be granted membership status.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that 59 applicants on the attached list are hereby enrolled into the membership of the White Mountain Apache Tribe, subject to rescission pursuant to the Tribal Enrollment Code, Section 1-202 and 1-704.

The foregoing resolution was on July 16, 1996, duly adopted by a vote of ten for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article II, Section 1 of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
