- BE IT FURTHER RESOLVED by the Tribal Council that it directs Mrs. Tortice to contact the Tribal Legal Department to obtain a proper bill of sale and ownership document which relieves the Tribe of any further responsibility for maintenance and repair of said home.

The foregoing resolution was on October 02, 1996, duly adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1(a), (h), (i), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
