

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, the Tribal Council is requested to donate \$30.00 to each of 15 Seven Mile Elementary Students traveling to Hawaii to perform as singers and to otherwise represent the White Mountain Apache Tribe; and

WHEREAS, the Tribal Council concludes that the request should be granted, said funds to be paid from the Tribal Chairman's Public Relations Fund.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes Tribal funds from the Tribal Chairman's Public Relations Fund to donate \$30.00 to each of 15 elementary students from Seven-Mile to assist them with traveling expenses to Hawaii where they will perform as singers representing the White Mountain Apache Tribe.

The foregoing resolution was on May 15, 1997 duly adopted by a vote of seven for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (i), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, District II Councilman Lynn Cody advises the Tribal Council that he has been requested by the Carrizo Community to request Tribal Council approval by resolution for funds from the Carrizo Community land claims fund to pay for necessary repairs to the Carrizo community building; and

WHEREAS, Councilman Cody understands that a petition signed by Community members must be presented to the Council to approve withdrawal of community land claim funds and Mr. Cody states he will submit the required petition to the office of the Council Secretary before funds are withdrawn from the land claims fund; and

WHEREAS, Mr. Cody requests the sum of Fifteen Thousand Dollars (\$15,000) from the Carrizo land claims fund to make necessary repairs to the community building and the Tribal Council concurs in the request.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the request of the Carrizo community for the amount of Fifteen Thousand Dollars (\$15,000) from the Carrizo community land claims fund to make necessary repairs to the Carrizo community building.

BE IT FURTHER RESOLVED by the Tribal Council that this approval is contingent upon Councilman Lynn Cody submitting a petition from the Carrizo community members to the Council Secretary's Office requesting that the above sum be used to repair the community building.

The foregoing resolution was on January 08, 1997, duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by the White Mountain Apache Tribal Constitution, including Article IV, Sections 1 (a), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
