

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, the Tribal Council of the White Mountain Apache Tribe has been advised that Mr. and Mrs. Charles and Sharon Allen Endfield has requesting enrollment for their son, Michael Endfield, whose birth day is July 21, 1991, with the White Mountain Apache Tribe; and

WHEREAS, Charles and Sharon Allen Endfield signed a conditional relinquishment for their son, Michael Endfield, with the San Carlos Apache Tribe on August 1, 1997; and

WHEREAS, the Tribal Enrollment Committee has completely reviewed Michael Endfield's enrollment application, and all supporting documents; and

WHEREAS, the Tribal Enrollment Committee finds that Michael Endfield, whose birth date is July 21, 1991, possesses a blood quantum of one fourth White Mountain Apache and four fourths total Indian blood; and

WHEREAS, the Enrollment Committee finds that Michael Endfield meets the blood quantum requirements set forth in the Constitution of the White Mountain Apache Tribe and is eligible for enrollment with the White Mountain Apache Tribe; and

WHEREAS, Michael Endfield has not receive any Court of Claims judgement funds, and thus would be eligible for a per-capita distribution of the White Mountain Apache Tribe Docket 22-H funds.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the request of Charles and Sharon Allen Endfield for membership for their son Michael Endfield into the White Mountain Apache Tribe based upon the recommendation of the Tribal Enrollment Committee, subject to the final execution of conditional relinquishment of membership from the San Carlos Apache Tribe and subject to rescission pursuant to the Tribal Enrollment Code Section 1-202© and 1-704.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Office of Vital Records to verify that Michael Endfield's membership in the San Carlos Apache Tribe has been fully and finally relinquished prior to adding his name to the enrollment records of the White Mountain Apache Tribe, and that if such relinquishment is not completed within sixty (60) days of the date of this resolution, the authorization granted in this resolution shall be void.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that pursuant to Resolution No. 04-96-085 and the Tribe's 22-H Distribution Plan, Michael Endfield shall be eligible to receive a distribution under Court of Claims case Docket 22-H, because Michael Endfield has not previously received Court of Claims funds while enrolled with the San Carlos Apache Tribe.

The foregoing resolution was on August 22, 1997, duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by the White Mountain Apache Tribal Constitution, including Article IV, Sections 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
