

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**WHEREAS,** the Tribal Council of the White Mountain Apache Tribe has been advised that Martin S. Harris has requested enrollment for his son's with the White Mountain Apache Tribe; and

**WHEREAS,** the Tribal Enrollment Committee has completely reviewed Cory and Josiah Harris' enrollment application, and all supporting documents; and

**WHEREAS,** the Enrollment Committee finds that Cory Harris, whose birth date is July 26, 1992 and Josiah Harris, whose birth date is July 17, 1990, possess one-quarter White Mountain Apache and three-quarters total Indian Blood; and

**WHEREAS,** the Enrollment Committee finds the Cory and Josiah Harris meet the blood quantum requirements set forth in the Constitution of the White Mountain Apache Tribe and are eligible for enrollment with the White Mountain Apache Tribe; and

**WHEREAS,** Cory and Josiah Harris were enrolled from birth with the San Carlos Apache Tribe, until they relinquished their enrollment effective July 11, 1997; and

**WHEREAS,** Cory and Josiah Harris have not received any Court of Claims Judgment funds and thus would be eligible for a per-capita distribution of the White Mountain Apache Tribe Docket 22-H funds.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants Cory and Josiah Harris' membership into the White Mountain Apache Tribe based upon the recommendation of the Tribal Enrollment Committee, and subject to rescission pursuant to the Tribal Enrollment Code, Sections 1-202 (c) and 1-704.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that pursuant to Resolution 04-96-085 and the Tribe's 22-H Distribution Plan, Cory Harris and Josiah Harris shall be eligible to receive a distribution under Court of Claims case Docket 22-H, because Cory Harris and Josiah Harris have not previously received Court of Claims funds while enrolled with any other Tribe.

The foregoing resolution was on August 22, 1997 duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
