## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe has been advised that Marty Hastings has requested enrollment for his daughter with the White Mountain Apache Tribe; and
- WHEREAS, a conditional relinquishment with the Navajo Tribe has been signed on August 13, 1997; and
- WHEREAS, the Tribal Enrollment Committee has completely reviewed Martay Hastings' enrollment application, and all supporting documents; and
- WHEREAS, the Enrollment Committee finds that Martay Hastings, whose birth date is, September 21, 1991 possesses a blood quantum of seven-sixteenths White Mountain Apache and seven-eights total Indian Blood; and
- WHEREAS, the Enrollment Committee finds that Martay Hastings meets the blood quantum requirements set forth in the Constitution of the White Mountain Apache Tribe and is eligible for enrollment with the White Mountain Apache Tribe; and
- WHEREAS, Martay Hastings has not received any Court of Claims judgment funds, and thus would be eligible for a per-capita distribution of the White Mountain Apache Tribe Docket 22-H funds.
- **BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants Martay Hastings membership into the White Mountain Apache Tribe based upon the recommendation of the Tribal Enrollment Committee, subject to the final execution of conditional relinquishment of membership from the Navajo Tribe and subject to rescission pursuant to the Tribal Enrollment Code Section 1-202 (c) and 1-704.
- BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that pursuant to Resolution 04-96-085 and the Tribe's 22-H Distribution Plan, Martay Hastings shall be eligible to receive a distribution under Court of Claims case Docket 22-H, because Martay Hastings has not previously received Court of Claims funds while enrolled with any other Tribe.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the office of Vital Records to verify that Martay Hastings' membership in the Navajo Tribe has been fully and finally relinquished prior to adding her name to the enrollment records of the White Mountain Apache Tribe, and that if such relinquishment is not completed within sixty (60) days of the date of this resolution, the authorization granted in this resolution shall be void.

The foregoing resolution was on <u>August 22, 1997</u> duly adopted by a vote of <u>eight</u> for and <u>zero</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
