

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

- WHEREAS,** the Tribal Council of the White Mountain Apache Tribe has been advised that Mr. Derran Yazzie has requested enrollment with the White Mountain Apache Tribe; and
- WHEREAS,** the Tribal Enrollment Committee has completely reviewed Derran Yazzie's enrollment application, and all supporting documents; and
- WHEREAS,** the Enrollment Committee finds that Derran Yazzie, whose birth date is April 7, 1977, possesses a blood quantum of one-quarter White Mountain Apache and 15/16 total Indian Blood; and
- WHEREAS,** the Enrollment Committee finds that Derran Yazzie meets the blood quantum requirements set forth in the Constitution of the White Mountain Apache Tribe and is eligible for enrollment with the White Mountain Apache Tribe; and
- WHEREAS,** Derran Yazzie was enrolled from birth with the Navajo Tribe, until he relinquished his enrollment effective prior to March 28, 1995; and
- WHEREAS,** Derran Yazzie has not received any Court of Claims judgment funds, and thus would be eligible for a per-capita distribution of the White Mountain Apache Tribe Docket 22-H funds.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants Derran Yazzie's request for membership into the White Mountain Apache Tribe based upon the recommendation of the Tribal Enrollment Committee, and subject to rescission pursuant to the Tribal Enrollment Code, Sections 1-202 (c) and 1-704.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that pursuant to Resolution 04-96-085 and the Tribe's 22-H Distribution Plan, Derran Yazzie shall be eligible to receive a distribution under Court of Claims case Docket 22-H, because Derran Yazzie has not previously received Court of Claims funds while enrolled with any other Tribe.

The foregoing resolution was on August 22, 1997 duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
