

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

- WHEREAS**, the Tribal Council of the White Mountain Apache Tribe has been advised the Davin Yazzie has requested enrollment with the White Mountain Apache Tribe; and
- WHEREAS**, the Tribal Enrollment Committee has completely reviewed Davin Yazzie's enrollment application, and all supporting documents; and
- WHEREAS**, the Enrollment Committee finds that Davin Yazzie, whose birth date is August 23, 1978, possesses a blood quantum of one-quarter White Mountain Apache and three-fourths total Indian Blood; and
- WHEREAS**, the Enrollment Committee finds that Davin Yazzie meets the blood quantum requirements set fourth in the Constitution of the White Mountain Apache Tribe and is eligible for enrollment with the White Mountain Apache Tribe; and
- WHEREAS**, Davin Yazzie was enrolled from birth with the Navajo Tribe, until he relinquished his enrollment effective March 28, 1995; and
- WHEREAS**, Davin Yazzie has not received any Court of Claims judgment funds and thus would be eligible for a per-capita distribution of the White Mountain Apache Tribe Docket 22-H funds.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants Davin Yazzie's request for membership into the White Mountain Apache Tribe based upon the recommendation of the Tribal Enrollment Committee, and subject to rescission pursuant to the Tribal Enrollment Code, Sections 1-202 (c) and 1-704.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that pursuant to Resolution 04-96-085 and the Tribe's 22-H Distribution Plan, Davin Yazzie shall be eligible to receive a distribution under Court of Claims Case Docket 22-H, because Davin Yazzie has not previously received a Court of Claims per-capita distribution while enrolled with any other Tribe.




